**POLICY:**

1. The mandate of the WCB Board of Directors is to represent Prince Edward Islanders in determining and ensuring organizational performance.

**POLICY NUMBER: POL-106**

Accordingly,

- A. The Board of Directors will be the link between the organization and Prince Edward Islanders.
- B. The Board of Directors will produce written governing policies which, at the broadest levels, address:
  - (i) *Ends*: Results for defined groups.
  - (ii) *Executive Limitations*: Constraints on the CEO's authority which establish the lawful, prudent and ethical boundaries within which all CEO activities and decisions must take place.
  - (iii) *Governance Process*: Specification of how the Board of Directors conceives, carries out, and monitors its own task.
  - (iv) *Board - CEO Relationship*: How power is delegated and its proper use monitored through the CEO role, authority, and accountability.
- C. The Board of Directors will produce assurance of CEO performance against policies in B (i) and B (ii) above and further defined by WCB policy, POL-112, Board - CEO Relationship, Monitoring CEO Performance.
- D. The Board of Directors will fulfill its legislative responsibilities as defined by the: *Workers Compensation Act*, R.S.P.E.I. 1988, c. W-7.1 and Regulations; and *Occupational Health and Safety Act*, R.S.P.E.I. 1988, c. O-1.01 and Regulations.
